Dermatology Associates of Kentucky, PSC is located off Man O' War and Blazer Parkway (between Richmond Road and Palumbo Drive). Our building is at the end of cul de sac of Fountain Court and we have two driveways.

If you are seeing Sean Marzolf MD, Fernando de Castro MD, Braye Rueff PA-C, Jamie Davis PA-C or have an appointment at BelleÂge Medispa, take the **left** driveway and enter that side of the building.

If you are seeing Mary Guiglia MD, Charlie Becknell MD, Laurie Massa MD, Todd Clark MD, April Ramsey MD, Tandy Repass MD, Ryan Fischer MD, Caitlin Pennington PA-C, or Stacey Smallwood APRN, take the **right** driveway and enter that side of the building.

From US 27, Nicholasville/Somerset areas

Take Nicholasville Rd. to Man O' War and turn right onto Man O' War
Follow Man O' War about 7 miles or 15 minutes to Blazer Parkway
Turn right onto Blazer Parkway, then the first left onto Fountain Ct.

From US 60, Frankfort/Lawrenceburg/Versailles areas

Take Versailles Rd. to Man O' War and turn right onto Man O' War
Follow Man O' War about 13.5 miles or 30 minutes
Turn right onto Blazer Parkway, then the first left onto Fountain Court

From US 68, Harrodsburg area

Take Harrodsburg Rd. to Man O' War turn right onto Man O' War
Follow Man O' War about 10 miles or 25 minutes
Turn right onto Blazer Parkway, then the first left onto Fountain Ct.

From Richmond/Berea/Mt. Vernon areas

Take I-75 North to Exit 104 – Athens/Boonesboro Exit
Turn left onto Richmond Rd. towards Lexington
Take Richmond Rd. to Man O' War and turn right onto Man O' War
Take first right onto Blazer Parkway, then the first left onto Fountain Ct.

From Morehead/Mt. Sterling (Eastern KY)

Take 64W/75S towards Lexington
Take the Man O' War Exit/Exit 108
Turn right onto Man O' War towards Lexington (Hamburg Pavillion)
Follow Man O' War approximately 2 miles and turn left onto Blazer Parkway
Take first left onto Fountain Court

From Georgetown/Paris/Paris Pike

Turn left onto New Circle Rd (East)
Take the Richmond Rd. Exit/Exit 15 and turn left onto Richmond Rd.
Take Richmond Rd. to Man O' War and turn left onto Man O' War
Take first right onto Blazer Parkway, then the first left onto Fountain Ct.
